2017 RULES AND REGULATIONS

1. The competition is for High School and Middle School cheering squads.
2. Middle School and High School units will be judged separately: Middle School competition will take place first; followed by High School.
3. All competitions will be judged on a unit basis. (Middle School - one unit, - High School - one unit).
4. There will be three judges.
5. Total performance time will be three (3) minutes.
6. Music is allowed but is not necessary. There will be no separation between teams with music and teams with no music.
7. The only props allowed are poms and signs.
8. All entries must be postmarked no later than June 30th. Preference will be given to early entries and Elkhart County Schools.
9. The cheerleader coach or adult designee must be present during his/ or her squad's performance.
10. The stage dimensions are 40' wide and 40' deep. Mats will be placed on the stage surface.
11. All teams are responsible for their own spotters.

WINNERS AND AWARDS

Placing will be announced soon after the completion of the competition. The top three (3) schools will receive a trophy.

Teams will be assigned an order and timed during the practice.
